THE KWALE COUNTY FINANCE BILL, 2014

A Bill for

AN ACT of the County Assembly relating to various Fees and charges and for matters incidental thereto

ENACTED by the County Assembly of Kwale, as follows—

PART I – PRELIMINARY

1. This Act may be cited as the Kwale County Finance Act, 2013, and shall come into operation, or be deemed to have come into operation, on 1st January, 2014; or on such date as the executive member for finance may appoint, by notice in the Kenya Gazette. All the existing charges shall continue to be levied till 31st December 2013

PART II – SINGLE BUSINESS PERMIT

Amendment to harmonise single business permit regime from schedule no 3 to schedule No. 4

2. All hotels and boarding lodges shall from 1st January 2014 pay bed levy of two dollar per bed occupant per night in place of the whole year rate as in the fees and charges. From this source the county government expects to collect an additional Kenya shilling sixty two million five hundred thousands

3. For this revenue to be realized there shall be appointed a single business inspector who shall have access to all lodging house record for the sole purpose of charging the business permit.

4. The county government shall appoint an agency to collect bed levy on behalf of the county

PART III – PROPERTY RATES

5. There shall be a charge of 2% on the value of land in the valuation roll charged annually and a penalty of 2% per month on the outstanding rates arrears. From this source of revenue the county government expects to collect annually Kenya shillings one hundred and sixty million.

6. This rate shall only apply to land that is ratable and valued by a registered valuer.

PART IV – PRODUCE CESS

There shall be a charge on all agricultural products entering our jurisdiction or transiting through our jurisdiction. This charge shall be as per attached schedule of fees and charges. This source of revenue we expect to collect Kenya shillings one hundred millions if the mining activities within the county are on schedule.

PART V ROYALTIES

7. There shall be a charge on all mining activities undertaken in the county of 15% on the rate charge by the national Government in accordance to the mining Act based on the gross turnover of the of the activity.

PART VI-PARKING FEE

8. There shall be a charge on all vehicles parking in our trading centre, designated parking lots , parking bays .Matatus and Buses plying within the county shall be charged as per the attached schedule. The charges shall vary according to the size of the vehicle. From this revenue source we expect to collect Kenya shillings five million.

PART VII-MARKETS AND SLAUGHTER HOUSE FEE

9. There shall be a charge for use of our open air markets and slaughter houses within our jurisdiction as per the schedule of fees and charges. This source we expect to collect Kenya shillings ten million.

PART VIII- CONSERVANCY FEE AND CHARGES (SOLID WASTE DISPOSAL)

10. There shall be a charge for solid waste disposal as per the attached fees and charges schedule. We expect to collect Kenya Shillings two millions

PART IX-APPROVAL FOR BUILDING PLANS AND SUB DIVISION OF LAND

11. There shall be a charge for approval of building plan as per the physical planning act based on built up area in square meters at a rate of Kenya Shillings 40 per square feet .Other chargers remain as per the schedule 1 attached. From this source the County Government intends to collect Kenya shillings 20 million

PART X HOUSE RENT

12. There shall be a charge to every tenant letting houses belonging to the County Government as per Annex I. From this source we expect to collect Kenya shillings two million.

PART XI-MISCELLANEOUS INCOME

13. This are incidental incomes that cannot be predictable that shall be a charge and called miscellaneous income. They shall consist of court fines, donations, application fees, sale of tender documents, disposal of assets, way leaves, cutting along/across public land/roads, advertisement fee, etc. From these sources we expect to collect Kenya Shillings twelve million

PART XII OTHER ACTS OF PARLIAMENT

14. All charges partaing to devolved fuctions under the Co-Operative Act, Weights And Measures Act, Cost Sharing Act, Veterinary Services Act, Liquor Licence Act and other relevant Acts of the nationl assembly shall be deemed to be county revenues and shall be charged at the prevailing rates
